#### CONTACT AND NATIONAL NETWORK OF PARENT CARER FORUMS CONFERENCE: 7 NOVEMBER

You will already have heard from Departmental officials that I am no longer able to speak at your conference on 7 November. I wanted to write and personally explain the position, and to apologise for having to pull out at such short notice and for the inevitable inconvenience and disruption that this will cause you.

I firmly believe that the system for special educational needs and disabilities (SEND) is improved if it is influenced strongly by the voice of parents, and children and young people with SEND. The work that parent carer forums up and down the country do to ensure that voice is heard, and to work in coproduction with local authorities and other organisations, is invaluable. Equally important is the work you do to provide leadership and direction, and to support, and input into, national policy. These are clearly having an important and positive impact and I am extremely grateful for all your hard work.


