To be flexible and holistic with the aproach not to assume the adults are at fault!

Empowering families to support themselves. Providing a teaching element to families. Providing safeguarding but also supporting parents. More practical support needs to be available.

Non judgemental help

To help and support families for as long as is needed with a clear exit plan for ongoing support if needed.

Work with the families, using language that is non judgemental, but person centred. Better training for social workers

# How do we address the tension between protection and support in Children's Social Care that families describe?

Good robust assessments by experienced social workers who can tell the difference

Need a tiered system which is relevant to CYP

To work with families not against them!

Separate the two

Listen ....and treat each case on it's own specific needs

I think it's all about how the social worker communicates with the family.

Mentors, advocates, more options for families to have someone there *for* them

Training on disabilities so that social workers understand the family needs

Using parent friendly language and working with families not against them.



### How do we address the tension between protection and support in Children's Social Care that families describe?

Don't mention 'child protection' when visiting parents first time or on phone call

Robust assessment that evidences the decision, not the assumption. The social worker needs to undertstand the difference

Better assessment. More experienced social care staff who stick with a family wherever possible. Different frameworks for different kinds of support needed.

Proper training for SW of the assessment process so that the right support is offered

Need to identify where social care support needs to be different for SEND families.

Come into the family environment with an open mind non judgemental approach. Use family friendly language. Build trust and listen to what parents tell you.

There with always be tension but 1st & foremost the social work remit should be to work alongside the family, building relationships.

Social care and families should be a partnership. Families should see this as help and not feel they are failing. The offer should be from early hel to family support to CWD.

Support needs to start with the words, "how can we help you and your CYP to live they way you want to live?"



# How do we address the tension between protection and support in Children's Social Care that families describe?

Working to understand family situation as a whole - rather than formulaic superiority approach.

Working with all families from a blank page starting point. No assumptions made before carrying out a thorough assessment.

Workforce development in relation to understanding families who live with SEND

Knowledge sharing. The multigenerational fear of social workers stealing away your kids runs deep. Accessible education around what various terms and processes entail is important.

How many families who self refer for support are child protection cases? They just want help.

Lack of trust and respect

Listen to parents who have experienced the system. Many families are immediately known to need support not investigation so put a process on place for them. We also need to acknowledge that some children will need protection, to avoid defensiveness

Change terminology so that support role is emphasised - create a different team to oversee child protection

Educate the professionals and do not blame the parents.

One standard procedure throughout the country. Working in partnership and not accuse of FII or similar if seen as a pushy parent. Genuine coproduction



### How do we address the tension between protection and support in Children's Social Care that families describe?

Clear communication and ongoing support to understand the process. Keeping families at the centre of the process.

Listen! We go to meetings with families and noone listens, they just talk at youThe working is not joined up with other professionals, they don't get back to you when they say they will, they use child protection as a threat, they don't actually do

It's OK to make mistakes. Don't use the protection use as a way of avoiding mistakes Tip the balance to 'support' and prevent mistakes.

Community involvement – everyone being able to talk together: wider family, school, health, CYP, etc. – to identify where difficulties lie and work in coproduction.

Stop judging parents and work with them.

By amalgamating both social care teams and children with disabilities teams, why segregate?

Properly trained staff who can differentiate CIN and Child Protection. Be curious not judgmental. Work with families

Appropriate training for social workers in order for them to support families in the way they need.

Have a clear offer that families understand, multi agency approach with trained staff. Not allowing one opinion to lead the whole investigation, a whole family approach





# How do we address the tension between protection and support in Children's Social Care that families describe?

Partnership

Joined up system for SEND support. SEND families should get this support as part of package

Start from a supportive approach. Listen... Framework that encourages social workers to seek guidance/ refer if NDP is mentioned and they are not that familiar with it

Possibly looking at individual teams. Seperating both protection to support especially in relation to SEND. Looking at specific SEND support teams or specific early help forms that schools can utilise rather than not being specific enough.

Training for ALL social workers in Neurodiversity.





### A possible definition of "family help"


The aim of Family Help should be to improve children's lives through supporting the family unit and strengthening family relationships to enable children to thrive and keep families together, helping them to provide the safe, nurturing environments that children need.

Family Help should be high quality, evidence-led and delivered by skilled professionals who are able to engage families and build trusting and supportive relationships with them. In delivering this support, Family Help should recognise that all families need help at times, and that does not mean there is a child protection concern.

This help should be available to any family that is facing significant challenges that could pose a threat to providing their child with a loving, stable, safe family life.


